

# **STALLS TERMS & CONDITIONS**

Stalls applications have to be approved by the Stalls Manager - there are no exceptions to this.

#### **PLEASE NOTE**

- a. All charges must be paid in advance.
- b. Stalls not registered properly and without a valid contract form will be removed.
- c. All goods must strictly conform to Islamic requirements or they will be removed.
- d. Any equipment brought by stallholders must be agreed upon prior to arrival and must not pose any type of hazard for the Event participants.
- e. Stall positions cannot be changed once established without the Event management's prior permission.

Please carefully read the **Terms & Conditions** below and do not hesitate to contact us if you require further assistance. Once your application is accepted, this becomes a legally binding contract.

## **TERMS & CONDITIONS**

- 1. Under no circumstances will any person be allowed to set up a stall unless they have applied and have been accepted by the Funday Management team and in particular, the Stalls Manager
- 2. All stallholders will be given one free parking space and 2 free adult entries only. If additional helpers are required to setup your stall then they will need to purchase tickets before being allowed access to the site.
- 3. The Event management reserves the right to accept or refuse any application at their discretion without disclosing their reasons
- 4. The Event management reserves the right to stop immediately the sales of any goods at the Event.
- 5. Please note that the stalls area is not a segregated area. However, all stallholders are expected to adhere to Islamic etiquettes, which include ensuring that all staff on your stall dress appropriately for a Muslim event. Failure to do so will result in the closure of your stall
- 6. Al-Noor gives no guarantee to the numbers that will attend this event and accepts no responsibility for the response to your stall.



- 8. The following items are strictly not permitted, Food of any kind, sweets, drinks or face painting.
- These will be provided entirely by the Event organisers themselves.
- 9. Under no circumstances can stallholders sell illegal items, banned products, promote illegal or immoral activities or support illegal groups/organisations.
- 10. No unauthorised advertising material can be distributed.
- 11. Stalls can be setup from 10am, Saturday 15th of July 2017 and 9am Sunday 16th July 2017 and not prior. All stallholders must be ready and setup with vehicles out of the main area with stalls secured firmly by 12 noon on Saturday 15th July and 11am Sunday 16th July 2017. All stallholders must have their stall closed and areas cleared by 7pm on both days.
- 12. All fixed charges must be paid before the Event.
- 13. Al-Noor has no provision if it rains and accepts no responsibility if any items are damaged due to the elements.
- 14. By accepting the offer of a stall, the applicant agrees to all the conditions stated therein.
- 14. Contravention of any of the above conditions will result in the closure of the stall and we will not allow you to have a stall at future Al-Noor events.

### **STALL COST & BOOKING**

All stallholders will be provided with a 10ft square space to promote and sell their products. Al-Noor will provide a single 6ft table and 1 chair. There is no electricity supply available for the stallholders. Al-Noor accepts no responsibility for any loss of goods during this event.

The stallholder is responsible for ensuring that all rules and regulations are strictly adhered to and that all rubbish is cleared at the end of each day. Any breach of this agreement will result in your stall being removed and you being barred from future Al-Noor events.

## **COST**

The cost of a single stall is £195.00 for both days.

Due to the increased costs of staging the event we are regrettably unable to offer any concession for multiple stalls.
